I further agree to assume liability for and indemnify, hold harmless, and defend the City of Lakeland and the Junior League of Greater Lakeland, Inc., including any of its officers, employees, volunteers, organizers, sponsors, participants and agents of, from, and against all liability and expense, including reasonable attorneys' fees in connection with any and all claims, demands, damages, actions, causes of action, and suits in equity of whatever kind of nature, including claims for personal injury, property damage, relief, or loss of use, arising out of my entry, participation and/or travel in any activities of any kind in any way connected to The Lakeland Christmas Parade whether or not due to or caused by the negligence of the City and/or the Junior League of Greater Lakeland, Inc., including all of its officers, employees, volunteers, organizers, sponsors, participants, representatives and agents. The obligations contained in this provision shall survive the termination of this Agreement and shall not be limited by any amount of insurance required to be obtained or maintained under this Agreement. Nothing contained herein shall be construed as a waiver of any immunity or limitation of liability the City of Lakeland may be entitled to under the doctrine of sovereign immunity or Section 768.28, Florida Statutes.
